### WHAT WE ARE DOING...

We are asking your help in funding the purchase and installation of Brussel Block pavers to create an attractive, safe and compatible piazza in front of the Ridgefield Community Center to provide an area distinct from parking and traffic for our frequent outdoor ceremonies and memorials.

### WHY WE ARE DOING IT...

You must have noticed the deteriorating condition of our driveways and parking lot. As a town owned building we will be assisted with paving, however the town paving crew cannot pave around our existing front pavers and they must be removed. We have been given the choice of completing the entire front area with pavers, or the entire front entrance must be returned to asphalt. We feel strongly that the piazza will add an important feature to the entrance and to outdoor functions.

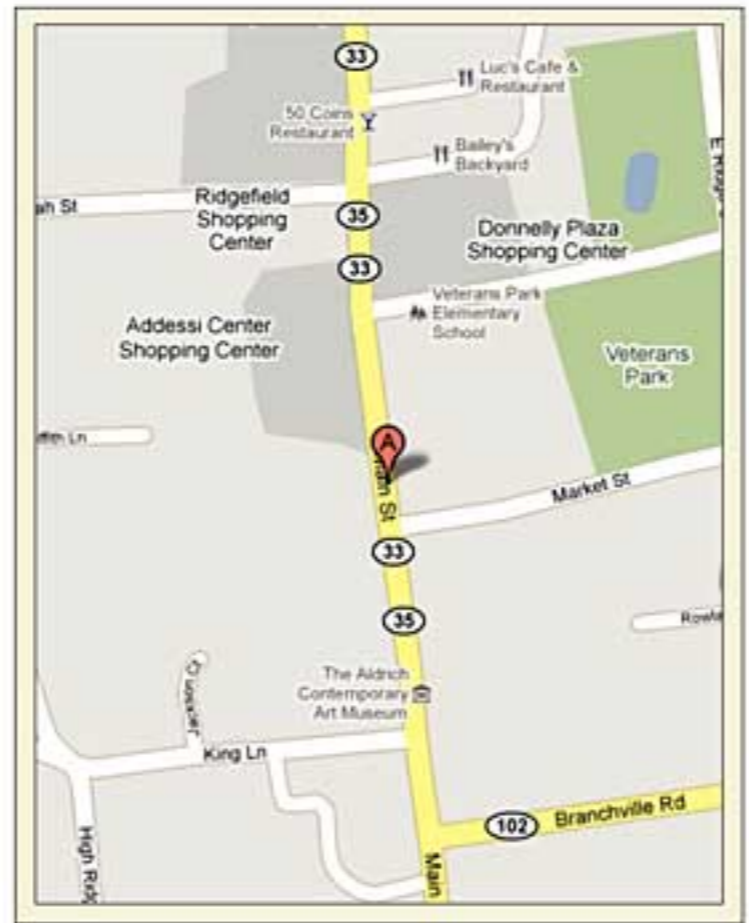
